

Dues for 2010-2011

New dues were approved at the April General Membership meeting. For the last two years, the base dues for Senior members were \$100 and a \$100 Defense Fund assessment was required. For 2010-2011, the base dues will be \$150, and there will be no Defense Fund requirement. Old Time dues will also be changed, from \$25 to \$50. Associate dues will change from \$5 to \$10. There is no change for Junior members; dues remain \$5. There is no change to the Building Assessment.

A new membership category was approved, the Family membership. Family dues will be \$225. This membership is for families that desire to have two HID gate access cards, one for the Senior member and one for the Associate member. The Family membership includes all minor children. Only the Senior member will have voting privileges. Contact VP Charlie McAlister if you are interested in converting to the Family membership.

The work obligations are also revised. In 2010-2011 all Senior members will be required to perform eight (8) hours of work. Old Time and Life members are exempted. Previously, the work obligation ended after five years. There are many ways to meet this work requirement: the Tuesday work mornings, the annual work day, hunter sight-in, helping at the gun shows and other promotional activities, serving on the Long Range Planning and other committees, assisting at matches, etc. Contact Project Coordinator Ron Carey or any Board Member if you have any questions about meeting the work obligation.

Richard F. Hans died March 15 at 87 years old, after a battle with cancer. Dick was born in Ponca, Nebraska in 1922.

Dick entered the Navy in 1940 and was commissioned to the U.S.S. Phoenix as a gunner. He was present at Pearl Harbor and at every major naval battle in the Pacific. His ship was one of the few to remain floating and able to keep fighting during the Pearl attack.

He was preceded in death by his wife, Alice Kelly, whom he married in Portland in 1948.

This list of long-range events Team Savage has won recently is getting almost as long as the distances they shoot at.

They recently added the 2010 F T/R National Championship to that list by taking the team competition in grand fashion. They won both the 600 and 1,000 yard events, establishing an new

1,000-yard record of 778-21X.

Darrell Buell of Damascus, OR; John Weil of Welches, OR; Monte Milanuk of Wenatchee WA and Stan Pate of Milwaukie, OR made the trip to Sacramento, CA to represent Savage Arms. The competition featured some of the best talent and most expensive custom rifles from around the Country. But, once again, those expensive custom guns were no match for four skilled marksmen armed with stock Savage Model 12 rifles.

“We continue to be thrilled with the winning results from Team Savage. Surviving are daughters Carol Jenquin, Barb Teyema, Jeanne Hubel, Denise Shields and son Jeff; 18 grandchildren and eight great-grandchildren; a brother, three sisters and many nieces and nephews.

OK to Have a Cup

The Brady Campaign to Prevent Gun Violence and Starbucks Corp. are squaring off over gun and concealed weapons laws.

The Washington, D.C., group has targeted the Seattle coffee giant, demanding that Starbucks outlaw the carrying of guns in its coffee shops. But Starbucks said it will comply with local laws and statutes.

“The political, policy and legal debates around these issues belong in the legislatures and courts, not in our stores,” Starbucks wrote in a statement released Wednesday.

Last month, Paul Helmke, president of the anti-gun group, wrote Starbucks CEO Howard Schultz, demanding that Starbucks reverse its current policy of allowing guns to be carried by its customers.

“Just as your stores may prohibit entry by people who are not wearing shoes, they may prohibit entry by people carrying guns,” Helmke wrote.

But Starbucks said it doesn’t want its employees to have to ask legal gun-carrying customers to leave its stores.

“Were we to adopt a policy different from local laws allowing

open carry, we would be forced to require our partners to ask law abiding customers to leave our stores, putting our partners in an unfair and potentially unsafe position,” Schultz said in his statement.

Starbucks operates 320 stores in Oregon.
